the second half on the first play after the kickoff. Nobody was anywhere near him when he crossed the line. This was one of the longest scrimmage plays of the entire season.

Blakely ran the ball, after kick-off, down the field to the four yard line and there tried to buck it over. Four attempts on the line failed miserably, the players being piled up regularly every time they started with the ball. Thomasville then ran from behind the goal line. Mays who had come into the game at fullback, hit the line on a fake punt, like a steam engine for eleven, twelve and nine yards. Lindsey got eight around end and then carried the ball thirty-five yards to the eighteen yard line on a cleave and run. In the fourth quarter the locals throw a forward pass to the three-yard line and Mays bucked it over.

In this quarter King kicked a perfect field goal for the visitors for their lone tally. This attempt came on fourth down after they had failed to gain an inch on three plays through the line. Lindsey and Singletary added long runs in this period and Lindsey carried the ball over from the three-yard line on a triple pass, being entirely away from any of the visiting players, who failed to diagnose the play, presumably looking for a line attack. Blakely fumbled near mid-field after the kick off and Washington grabbed the ball and made the final touchdown for the local team, running forty yards. The visitors tried four forward passes after the kick off, in an effort to score, but failed, Thomasville intercepting the last one. Lindsey intercepting the. The game ended with the ball in Thomasville's possession.

Thomasville played an erratic game, but at crucial moments showed their old-time form. The tackling was hard and fierce and the visitors were forced to take out time repeatedly, especially during the last of the game. Washington was the defensive star of the game, showing up brilliantly and making certain a berth on the All Star Association team, at end. He is one of the safest and most dependable ends in the entire South Georgia League. Lindsey's brilliant work entitled him to unquestioned ranking as a half back, and Mays at full back, has both the power to hit the line for gains at will and is one of the most desirable defensive full backs ever developed in this section of the state. Elrod and Stacey played great games and both are hard boys to handle at any time. The work of Lambert is especially noteworthy, as he is a very efficient player of defensive work and runs interference with uncanny accuracy and success. He hits like a fiend and rarely ever misses a tackle. Carl Singletary against demonstrated his generalship and his spirit in running the team and showed that he is a mean man to down when he starts with the ball. His gains yesterday were more than noteworthy against effective opposition. For the visitors, King was the star, and showed himself one of the cleverest all around players among the weaker teams of this association.

MADE CARTER CASE

AGAIN IS ON TRIAL

Jesup, Ga., Dec. 1.—The famous Mage Carter case which was transferred from Pierce Superior Court to Wayne county Superior Court, was begun yesterday morning at 8 o'clock in the Wayne county court house with Judge J. P. Highsmith presiding as Judge, and Col. Memory of Blackshear and Col. Spence of Waycross and Col. Gibbs of Jesup, representing the state, and Cols. James R. Thomas and J. W. Walker of Jesup, representing the defendant, Mage Carter.

It will be remembered that Mage Carter shot and killed Sheriff Robertson of Blackshear, about one year ago was tried in the Pierce county Superior Court and was convicted and sentenced to hang. A motion for a new trial was filed upon a plea that it had been discovered that a relative was on the jury. The new trial was granted and also a change of venue was granted and the case was assigned to Wayne county Superior Court.

The jury was sequestered about noon and the examination of witnesses was begun immediately after the noon


